## Funding monitoring Tool to help you find the right grant.

Since 2019, UTC has subscribed to Open4Research, a funding monitoring tool dedicated to researchers in need of research grants.

As a UTC researcher (starting with doctoral contract), you have access to it: it allows you to look for potential opportunities among more than 7000 different grant Calls identified, sorted by financial needs: research, development and innovation, equipment, mobility through international collaborations, trainings, communication to society - points we also find in the UTC HRS4R action plan (Human Resources Strategy for Researchers) leading to the award of the label Human Resources Excellence in Research in December 2016. HRS4R strategy is based on the European Charter for Researchers and the code of conduct for recruitment of researchers.

Open4Research, it is above all thousands of updated offers, opportunities throughout your research career, possibilities to create keyword alerts for your research,...

Horizon Europe , and other funding opportunities from Europe and other international research opportunities

Horizon Europe is the EU's research and innovation framework program for 2021-2027 with a budget of €95.5 billion.

In this program, research activities are organized by competitive calls for projects launched by work programs and by themes. There are also bottom-up calls. You can find COST actions which are funded for networking.

The organization is based on 3 pillars (Excellent Science / Global Challenges and European Industrial Competitiveness / Innovative Europe) and a cross pillar (Widening participation and Strengthening the European Research Area).

The focus is on changes and novelties in this program: Open science is strengthened, the gender issue is also deepened with the obligation of the Gender Equality Plan, the establishment of missions and the sustainability of the European Innovation Council (EIC).

France can thus participate in different EUREKA clusters: CELTIC-NEXT (new/next generation communications), EUROGIA2030 (sustainable energy solutions), ITEA 4 (software innovation and digital transition), SMART (advanced manufacturing) and Xecs (electronic components and systems and applications).

# Pôle Valorisation et Partenariats (PVP)

PVP can help you every step of the way, from the idea of your project to the valorization of your results.

### PVP provides:

- assistance to identify partners;
- drafting, negotiation and signature of non-disclosure agreements (NDA);
- assistance to find the right call for proposals to fund your project;
- review of your application, help for budget planning;
- check that your application meets the eligibility criteria;
- coordination with your partners (budget planning, administrative documents, etc.);
- validation of your application by the management of UTC;
- submit your application via the funder's platform.

Once your project has been accepted, PVP is in charge of:

- drafting, negotiation (intellectual propriety rights, confidentiality, etc.) and signing of the research collaboration agreements with your partners and the management of UTC;
- assisting you with data management plan writing,
- helping you determine if your results can be protected and transferred to the economic society;
- assisting you with invention disclosure filing,
- finding out intellectual propriety rights,
- mandating SATT (Technology Transfer Office) Lutech for evaluation of your results regarding valorization potential,
- coordinating with SATT Lutech the prematuration and maturation of your invention
